Business and Investment Visas, including EB-5, E2 and H-1B

EB-5 Visa

The EB-5 immigrant investor visa program was established in the Immigration Act of 1990 to create U.S. jobs by attracting foreign capital to the United States. 10,000 immigrant visas per year are available to qualified individuals seeking to obtain permanent residence in the U.S. Permanent resident status under the EB-5 category is available to investors, either alone or coming with their spouse and unmarried children (under 21). A qualified alien investor must invest in a new commercial enterprise, invest \$1 million or \$500,000 in a Regional Center or in a "targeted employment area", and create at least 10 positions for US citizens or authorized immigrant workers.

The immigrant investor, or EB-5, program is a highly beneficial permanent residence option for the wealthy individual. Since there is no quota waiting list in this preference category, it enables a foreign national to obtain permanent residence status more expeditiously than with most other options.

EB-5 投资移民签证是在 1990 年移民法中设立的，专门针对海外投资移民者的移民签证。每年有一万个签证名额授予这些寻求在美国永久居民身份的合格申请者。EB-5 移民种类下的永久居民身份不仅为投资者本人，也为投资者的配偶及其 21 岁以下的未婚子女设立。合格的投资者必须投资一个新的商务性企业，投资 100 万或投资 50 万在区域中心或在“目标就业地区”，并创造至少 10 个就业机会。

EB-5 投资移民签证对于投资者来讲是一个高受益性获得永久居民身份的选择。在这类签证类别下没有排期的等待，它是美国所有移民类别中，获得永久居民身份最便捷的一条通道。

E-2 Visa

The E2 Treaty Investor visa allows nationals from countries that have treaties of commerce and navigation or bilateral agreements in effect with the U.S., to enter the U.S. for the purpose of directing and developing the operations of an enterprise they have invested in, or are in the process of investing a substantial amount of capital. Treaty investors may be accompanied or followed by spouses and unmarried children who are under 21 years of age.

E-2 条约投资者签证针对的是与美国订有投资协议的国家，在美国已投资企业或在投资阶段，旨在指导或发展企业的投资人所设计的一类签证。E2 签证持有者的配偶及 21 岁以下未婚子女可以同时获得 E2 签证进入和居住在美国。

H-1B Visa

The H-1B category of nonimmigrant visa enables professionals who have a bachelor's degree or equivalent college-level education to live and work in the U.S. legally. It allows U.S. employers to employ foreign guest workers skilled in specialty occupations only when qualified U.S. citizens or residents are not available. H-1B petition must be filed by the employer. H-1B work-authorization is strictly limited to employment by the sponsoring employer. This is a temporary work visa that is initially valid for three years, but can be extended to a maximum stay of six years.

H-1B 签证是美国移民局签发给具有“专业技能”的外国人的一种短期非移民签证。该类别的签证应该由雇主为雇员提出申请，雇员必须具备在任何国家内取得的本科（或以上）学历（或同等学历）。为了保护本国劳工市场，美国政府要求可申请 H-1B 签证的职位必须是要求专业技术或知识的工作，此类工作要求受聘人员在本专业领域具有本科或以上学历（或相关学历）。此类签证为临时性工作签证，最初的有效期为三年，但可以延期最长至六年。
